STUDENT recognizes that STUDENT may be dismissed from STUDENT'S course of instruction if STUDENT'S instructor ascertains that STUDENT is engaging in the practice of using STUDENT'S martial arts training for the purpose of engaging in street fighting or causing similar disturbances in the community. STUDENT further recognizes that 606 Karate & Self-Defense is not responsible for

the STUDENT'S actions outside of the school. STUDENT also agrees that 606 Karate & Self-Defense shall not be liable for any items of personal property lost, stolen, or destroyed while on the School's premises.

STUDENT further agrees and acknowledges that participation in this training includes possible exposure to and illness from infectious diseases including, but not limited to MRSA, influenza, and COVID-19. While particular rules and personal discipline may reduce this risk, the risk of serious illness and death does exist. In addition, STUDENT willingly agrees to comply with the stated and customary terms and conditions for participation in the training as regards protection against infectious diseases. If, however, STUDENT observe anything STUDENT considers as an unusual or significant hazard during STUDENT'S presence or participation in the training, it is STUDENT'S responsibility to remove STUDENT from further participation, with the understanding that no refunds will be provided.

STUDENT'S participation is entirely voluntary and with a full understanding of that all such usage involves all manner of hazards and dangers. STUDENT chooses to participate in spite of the risks. STUDENT ACCEPTS AND ASSUMES ALL RISKS, BOTH KNOWN AND UNKNOWN, WHETHER CAUSED OR ALLEGED TO BE CAUSED BY THE NEGLIGENCE OR GROSS NEGLIGENCE OR OMISSIONS OF THE SCHOOL. STUDENT has a responsibility to themselves and other users/participants of the SCHOOL, to conduct themselves in a safe manner. If STUDENT is unsure about how to safely engage in any activities at any time, STUDENT will ask SCHOOL teacher/assistant/staff for further instruction BEFORE participating.

STUDENT is in good health and has no condition that would affect STUDENT'S safe participation in the activities, or else STUDENT assumes and agrees to bear the costs of all risks that may be created, directly or indirectly, by such condition.

STUDENT will not use the SCHOOL while under the influence of drugs or alcohol or while in any other condition that might impair THE STUDENT.

STUDENT has adequate insurance to cover any injury or damage THE STUDENT may cause or suffer while participating in the activities, or else THE STUDENT agrees to bear the costs of such injury or damage.
